ADDENDUM No. 1 – DATE: October 9, 2017

To All Bidders:

This Addendum amends or supplements the original specifications and related documents for this project. Please include a copy of this Addendum with your bid submission to prove receipt of the Addendum and its terms.

1. Change of Bid Date and Time:

Revise the first paragraph of the **NOTICE TO CONTRACTORS** to read as follows:

*“Sealed bids addressed to the Director of Public Service, City of Hilliard, Council Chambers, 3800 Municipal Way, Hilliard, Ohio 43026 and endorsed “CIP T-21/T-129 Scioto Darby Road and Leppert Road Improvements” will be received by the City of Hilliard, Franklin County, until **Wednesday, October 25, 2017 at 2:00 p.m.**, at which time and place all bids will be publicly opened and read aloud.”*

Also revise the Bid Opening Date/Time in the last sentence to match the above.

Revise the second sentence in the first paragraph of Section 1. RECEIPT AND OPENING OF BIDS in the **INFORMATION FOR BIDDERS** to read as follows:

*“Bids will be received by the Owner at the office of the Department of Public Service until **Wednesday, October 25, 2017 at 2:00 p.m.**, at which time and place all bids will be publicly opened and read aloud.”*

2. Cut Off Date for Inquiries:

Add the following sentence to the third paragraph from the bottom of Page 6 of the **NOTICE TO CONTRACTORS**:

*“Inquiries for contractual or technical questions will be received in writing until **Wednesday, October 18, 2017 at 2 p.m.** No further inquiries will be received after this time.”*

Replace the eighth sentence of Section 13. ADDENDA AND INTERPRETATIONS in the **INFORMATION FOR BIDDERS** with the following:

*“Inquiries for contractual or technical questions will be received in writing until **Wednesday, October 18, 2017 at 2 p.m.** No further inquiries will be received after this time.”*

3. CADD Files:

Add the following to the third paragraph of the **NOTICE TO CONTRACTORS**:

“CADD files are available for download for informational purposes only and are not a part of the Contract Documents, Specifications, or Plans. The City of Hilliard and Burgess & Niple make no performance guarantee, express or implied warranties, and assume no obligation or liability for the reliability or accuracy of the information contained in these files. All bids shall be based on the information provided in the Contract Documents, Specifications, and Plans.”

4. PLANS:

Replace the following sheets with the revised sheets provided as part of this Addendum:

Sheet 11 (General Summary)
Sheets 143, 160, 161, & 163 (Lighting Plan and Details)

Changes to the bid schedule that reflect revisions to General Summary Sheet 11 will be provided by Addendum on or before October 20, 2017.

This Addendum shall be considered in submitting your bid and shall be attached to Appendix A - Bid Schedule and made a part thereof. Please sign and date below and include as part of your bid submittal to acknowledge receipt of Addendum No. 1.
