This addendum is a modification of the Contract Documents for the Center Street Public Space, Parking Lot, and Trailhead Improvements (CIP LB-17) project for the City of Hilliard and is hereby incorporated into and becomes part of said documents. This addendum does not modify the due date. Please note the receipt of this addendum on the Bid Form. It is to be considered in the proposals and covers additions or changes as follows:

ADDENDUM NO. 1

- ITEM 1 Plan Sheets 15, 16, 17, 18, and 19 have been replaced by replacement plan Sheets 15A, 16A, 17A, 18A, and 19A.
- ITEM 2 Bid Schedule – revised Bid Schedule attached to Addendum #1 (8 pages) replaces the Bid Schedule in the original bidding document, Sheets 14-21.
- ITEM 3 Sheet 3 of bidding document - Engineer’s Estimate for the project has been revised to \$917,750
- ITEM 4 Pervious Pavers shall be Unilock Eco-Optiloc in Rustic Red or approved equal.
- ITEM 5 Cost for the 8”x16” header curb adjacent to the pervious pavers shall be included in the cost for Line 21, “Item SPEC - Pervious Concrete Pavers including Aggregate Base Buildup”.
- ITEM 6 Bid Schedule - the quantity for Line 7, “Item 203 – Excavation” includes excavation for the pervious paver aggregate base.
- ITEM 7 Bid Schedule - revised description of Line 78, “Item Special – Permanent Steel Bollard, Per RM-5.1”
- ITEM 8 Lighting notes have been updated and lighting quantities have been revised. See replacement plan Sheets 15A-16A and the revised Bid Schedule.
- ITEM 9 GFI outlets have been added to the light poles and wiring to the pole has been revised. See replacement plan Sheets 17A-19A and the revised Bid Schedule.
- ITEM 10 Plan Sheet 2, General Summary of Quantities - lighting quantities have been updated. See updates on the revised Bid Schedule also.
- ITEM 11 Bid Schedule – revised to include changes to the following items:
 - A. Line 36, Item 1001, 3” Conduit, Concrete Encased, As Per Plan
 - B. Line 38, Item 1001, Underground Circuit, 2-Wire (MIS-403)
 - C. Line 39, Item 1001, Underground Circuit, #2AWG, 3-Wire, As Per Plan
 - D. Line 44, Item 1001, Connector Kits
 - E. Line 78, Item SPEC, Permanent Steel Bollard, Per RM-5.1
