**ORDER**  
**Continued Closure of City Facilities and Cancellation of City Events**

On April 27, 2020, Governor Mike DeWine issued an Order and Guidelines to re-open the Ohio Economy, however, he continued the stay-at-home order, kept in place the limit on mass gatherings, and ordered the continued closure of recreation centers, senior centers, events, day camps and pools. As a result, it is necessary for the City to issue the following orders:

- Extending the closure of all City buildings and facilities to the public, which includes the closure of the Community Center, Senior Center, and all public restrooms in the parks, as well as programs, activities, and rentals until such time as the State of Ohio allows these facilities to be reopened;
- Cancelling all scheduled special events hosted by the City of Hilliard through June 30, 2020;
- Closing of the Hilliard Family Aquatic Center, the Clyde "Butch" Seidle Community Pool, and splash pads for the entirety of the 2020 season. Refunds will be issued to those who had already purchased pool passes for this year.
