ORDINANCES

The second reading/public hearing on the following Ordinance will be January 22, 2024.

24-01 AUTHORIZING THE CITY TO ENTER INTO A COLLECTIVE BARGAINING AGREEMENT WITH THE FRATERNAL ORDER OF POLICE, OHIO LABOR COUNCIL; AND APPROPRIATING FUNDS.

WHEREAS, the collective bargaining agreement between the City and the Fraternal Order of Police, Ohio Labor Council expired on December 31, 2023; and

WHEREAS, through the course of negotiations, the parties were able to arrive at a tentative agreement for the three-year period, commencing January 1, 2024, and continuing to December 31, 2026; and

WHEREAS, on December 21, 2023, City Staff was notified that the union membership had voted to accept the proposed agreement; and

WHEREAS, the Administration is recommending that the proposed agreement, attached hereto as Exhibit "A" and incorporated herein, be approved and appropriating additional funds as needed are in the best interest of the City; and

WHEREAS, Ohio Revised Code Section 4117.10 (B) requires City Council to approve or reject the submission as a whole within 30 days after the Administration submits it for City Council's consideration.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hilliard, Ohio:

SECTION 1. The City Manager, the Director of Human Resources, the Finance Director, the Law

Director, and such other officials deem necessary, are hereby authorized and directed to execute an agreement on behalf of the City of Hilliard with the Fraternal Order of Police, Ohio Labor Council pursuant to the tentative agreement reached in accordance with the terms and conditions attached hereto as Exhibit "A" and incorporated herein, excepting any typographical and/or grammatical edits that may needed for the

Agreement to be in final form for execution.

SECTION 2. An appropriation in the amount of \$22,275.89 is authorized from Fund 101, Object 107

to fund personnel costs in 2024.

SECTION 3. This Ordinance shall be in effect from and after the earliest time provided for by law.
